MONNIG, Oscar (M.D.), Surgeon, Co. L, 49th Missouri Infantry, 9 Sept. 1864 to 2 Aug. 1865, P.O. Add: Americus, Mo.

BACON, Absolom, Private, Co. I, 39th Ohio Infantry, 4 July 1861 to 26 Dec. 1863 (2 yr., 5 mo., 22 da.) P.O. Add: Americus, Mo.

BACON, Absolom, Private, Co. I, 39th Ohio Infantry, 22 Dec. 1863 to 8 June 1864 (5 mo., 16 da.) P.O. Add: Americus, Mo. (Same person as above)

MORGAN, William F., Private, Co. F, 36th Iowa Infantry, 15 Aug. 1861 to Aug. 1863, P.O. Add: Bluffton, Mo. Disability: Paralysis of both legs. Remarks: Discharge lost and date forgotten.

BOATRIGTH, William F., Private, Co. G, 25th Illinois Infantry, 10 Sept. 1862 to 21 Sept. 1862 (11 da.) P.O. Add: Bluffton, Mo. Disability: General health impaired on account of measles while in service.

GROTEWEIL, Bernhard, Private, Co. H, 12th Missouri Infantry, 23 Sept. 1861 to 23 Sept. 1864 (3 yr.) P.O. Add: Bests Bottom, Mo.

HEYING, Bernard, Sergeant, Co. M, 2nd Missouri Artillery, 7 Sept. 1861 to 11 Oct. 1863 (2 yr., 1 mo., 4 da.) P.O. Add: Rhineland, Mo. Disability: Injured from fall from horse.

POTTERBAUM, John, Private, Co. C, 9th Missouri Cavalry, 8 Feb. 1862 to 17 Feb. 1864 (2 yr., 9 da.) P.O. Add: Rhineland, Mo.

KENDRICK, John, Bugler, Co. C, 9th Missouri Cavalry, 1 Jan. 1862 to 17 Feb. 1864 (2 yr., 1 mo., 16 da.) P.O. Add: Rhineland, Mo.

MUEHL, Thuiske, Private, Co. C, 1st Missouri Artillery, May 1861 to June 1864 (3 yr., 1 mo.) P. O. Add: Rhineland, Mo. Disability: Wound in face by shell. Remarks: Discharge not at home.

FLUCHTE, Antone, Bugler, Co. F, 2nd Missouri Artillery, 11 Sept. 1861 to 13 Oct. 1864 (3 yr., 1 mo., 2 da.) P.O. Add: Rhineland, Mo.

ELSENRAAT, John H., Private, Co. C, 9th Missouri Cavalry, 14 Dec. 1861 to 17 Feb. 1864 (2 yr., 2 mo., 3 da.) P.O. Add: Rhineland, Mo.

NELLESEN, Herman, Private, Co. K, 12th Missouri Infantry, 23 Aug. 1861 to Dec 1861 (3 mo.) P.O. Add: Rhineland, Mo. Disability: Typhoid fever 3 months.

VAN WILLICK, Henry, Private, Co. A, 1st Missouri Cavalry, 10 Sept. 1861 to 10 Sept. 1864 (3 yr.) P.O. Ad: Rhineland, Mo.

HOLGUM, William, Private, Co. K, 12th Missouri Infantry, 31 Aug. 1861 to 15 June 1864 (2 yr., 9 mo., 14 da.) P.O. Add: Rhineland, Mo. Disability: Shot through left leg

HAGEDORN, Henry, Musician, 4th Missouri Cavalry, 27 Aug. 1861 to Sept. 1862 (1 yr., 1 mo.) P.O. Add: Rhineland, Mo.
